Article 1 CMU has formulated the Guidelines to award outstanding freshmen for enrolling in the School of Medicine, the School of Chinese Medicine, and the School of Dentistry. Article 2 Qualifications and scholarship amount awarded to outstanding freshmen are regulated as follows:

1. Qualifications:

- (1) Freshmen students who were accepted into the School of Medicine, the School of Chinese Medicine, and the School of Dentistry of CMU through independent admission applications who also received admissions to the School of Medicine or other equivalent Schools at national universities (National Taiwan University, National Yang-Ming University or National Cheng Kung University).
- (2) Freshmen students who were accepted into the School of Medicine, the School of Chinese Medicine, and the School of Dentistry of CMU by passing the Joint College Entrance Examinations whose exam scores have also attained the admission standards for the School of Medicine or other equivalent Schools at national universities (National Taiwan University, National Yang-Ming University or National Cheng Kung University).
- (3) Freshmen students who were accepted into the School of Medicine, the School of Chinese Medicine, and the School of Dentistry of CMU by recommendation through the Multi-Star Program who also scored 75 gradepoints or higher in the General Scholastic Ability Test.

2. Scholarship Amount:

- (1) Students who qualify under (1) and (2) of the previous paragraph will be awarded NT\$200,000 per person for the first year of their enrollment in CMU. Starting from the second year, those ranked top 20% of the class or school in their respective year in the previous semester will be awarded NT\$100,000 per person in the current semester.
- (2) Students who qualify under (3) of the previous paragraph will be awarded NT\$100,000 per person.

Article 3 Special remarks for claiming the scholarship are as follows:

1. Students who claim this scholarship shall not claim the Grants for Outstanding Students Admitted through the Joint College Entrance Examinations as stipulated in Article 7 of the CMU Student Grant Guidelines.
2. Students who have previously claimed this scholarship shall be required to return the full amount of the scholarship if they transfer to another school before graduation.

Article 4 The Medical Student Scholarship Review Committee shall be convened by the Dean of Academic Affairs. The Dean of the College of Medicine, the Dean of the College of Chinese Medicine, the director of the School of Medicine, the director of the School of Chinese Medicine, the director of the School of Dentistry, the director of the Office of Finance, and the

Chief of the Registration and Curriculum Section shall serve as committee members. The chairman and the members form the CMU Scholarship Review Committee for Elite Medical Students and are responsible for processing the application, selection, review and awarding of the scholarship to elite students in medicine.

Article 5 The Guidelines shall be implemented after approval is obtained in an Administrative meeting and from the President of CMU. The same shall apply to all subsequent amendments.
